Founded in 1967, MOSS Srl is an Italian manufacturer specializing in dry-offset and screen printing machines, hot-foil and flexographic technologies. MOSS is present in more than 100 countries, MOSS has become a global leader in its industry.

Presence in India: MOSS has been active in India since 2019, primarily in Chennai (Tamilnadu). MOSS expanded operations by manufacturing home appliances (washers, ovens, refrigerators, and laundry appliances). MOSS entered into a technology transfer agreement with a local partner, for production of MOSS machines in India, which strengthened its footprint in the region. As a result, MOSS expanded its operations in India's home appliance market. In 2024, MOSS employed 400 people in India and reinforces its global presence. 12.20 -12.30

Presence in India: MecVel Technologies Private Limited was founded in New Delhi in 2017. The company has grown to consolidate its position in India and become an independent company from the production point of view, with a new plant in Pune, Maharashtra. The company has two ranges of products fully manufactured in India.

Maire Technimont is a technology and engineering group that develops and implements solutions to enable Energy Transition, specializes in plant construction (especially in oil and gas), green chemistry and development of energy transition technologies. Maire Tecnimont SpA leads in transformation of natural resources (plant engineering in downstream oil & gas. Through its subsidiary NextChem it operates in green chemistry and technologies to support energy transition. The Maire Tecnimont Group is present in approximately 45 countries, with 50 operating companies.

Presence in India: In 1958 the ICB Company (Industrial Consulting Bureau Private Limited) started its engineering services in Mumbai. In 1996, Tecnimont acquired 50% of ICB, renamed as Tecnimont ICB Private Limited (TICB). In 2007 the Indian company Tecnimont Pvt. Ltd. becomes a fully owned subsidiary of Maire Tecnimont Group. The company has over 3000 employees. In 2022, Technimont Pvt Ltd expanded and opened two new offices in Airoli, Navi Mumbai, Maharashtra. resulting in six offices in India. In India it has set up over 20 fertiliser plants and 40 plants.
